Sir,  
With due respect, I am producing herewith one arrested accused person namely **Subal Debnath s/o Lt. Nipen Debnath of Barivasha, PS- NJP, Dist.- Jalpaiguri** under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 10 (Eight) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
2. 06 (Six) bottle of Himalayan FATA FATI 70up country sprit(each bottle cantaining 300ml)

I, ASI-Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 11.07.2022 at 22.15 hrs I received a secret source information that one person namely Subal Debnath s/o Lt. Nipen Debnath of Barivasha, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his home at Barivasha, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 555 dated 11.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/306 Biswajit Roy, CV/824 Niru Kumar Yadav all of NJP PS, SPC left for Barivasha, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 22.40 hrs hrs we arrived at Barivasha , and being identified by the source I held raid at the house of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 22.50 hrs to 23.15 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Subal Debnath s/o Lt. Nipen Debnath of Barivasha, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
