Nipen Debnath of Barivasha, PS- NJP, Dist.-Jalpaiguri is selling ID liquor illegally at his home at Barivasha, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 555 dated 11.07.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/306 Biswajit Roy, CV/824 Niru Kumar Yadav all of NJP PS, SPC left for Barivasha, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 22.40 hrs hrs we arrived at Barivasha, and being identified by the source I held raid at the house of the said accused and managed to apprehended him.
