Sir,
I, Ayesha Khatun (23) w/o Md. Gulam Rabbani
presently residing at my father's home at 90
Md. Omer, Coal Depo (Near Madrasa), Ward No 7
Sme, P.O & Siliguri Bazar, P.S-Siliguri, Distt. Durgam
beg to inform you that, on dt. 08.07.2022 at about
09:30 am, when I was at my matrimonial home at
Coal Depo, ward No 7, P.S-Siliguri at that time,
my husband & his below noted relatives, stated
abus demanding 02 (two) lakhs money from my
parental home as dowry, when I told that my
parents are poor and they can not give such a
huge amount again as dowry then they started
beating me brutally, with fist & blows and
I received severe injury on my person and
I am admitted at Siliguri Distt. Hospital.

Sir, my marriage was solemnized nearly
04 (four) years back, with Md. Gulam Rabbani
and since after my marriage, my said husband
namely (1) Md. Gulam Rabbani s/o Md. Wasi &
his relatives namely (2) Md. Wasi s/o Lt. Md. Rajjok
(3) Nazim Khatun s/o Md. Wasi (4) Sabina Khatun
(5) Sabi w/o Md. Ehsan (6) Md. Ehsan s/o Md.
Lal (6) Budiya Begum w/o Md. Javed (7) Md. Javed
s/o Not known (8) Md. Anwar (9) Buddu s/o Md. Javed
(10) Afsana Khatun w/o Md. Anwar (11) Buddu (12)
Md. Azmat @ Chhote s/o Md. Javed, all are resident
of Coal Depo, ward No. 7 Sme, P.O & P.S-Siliguri,
and (11) Tabbassum Begum w/o Md. Jamil &
(12) Md. Jamil s/o Not known, both are resident of
Dangipara, ward No-6 Sme, P.O & P.S-Siliguri, are
demanding more dowry from me & my parents
and on the said date & time they subjected me
for physical & mental cruelty for demand of
dowry, and threatened me that they will pour
kerosine oil and burn me, if I will not
bring dowry from my parents, and since I
am feeling unsafe at my matrimonial home, I
am staying at my parents home at Coal Depo.
So, please take necessary action against
the above named my husband & his above noted
relatives.
