Dear Sir,

With due respect, I am to state here that on 10.07.22 midnight (at 03:30 AM), the patient Mr. Sujit Kumar Debnath of 32 No Ward, Siliguri was admitted on 08.07.22 for chemotherapy. He called his family and relatives over mobile phone on 10.07.22 due to some hallucinations. The patient forced to come down from his bed, met his family and suddenly started a huge chaos in the reception and General Male ward, where many other patients were sleeping.

They went on saying that we have hacked his daughter's mobile and showing their family photos on TV. Whereas in the whole 1st floor is there no TV. Question of hacking of anyone's mobile does not occur.

We had explained the patient attenders about the hallucinations.

But they became violent and kicked the main door of our Hospital broke the hatch bolt of our main door by repeated kicking. Due to this chaos all other patients become horrified.

So please take necessary and urgent steps to stop such vandalism without any reason. We are ready to co-operate with you in the investigations.
