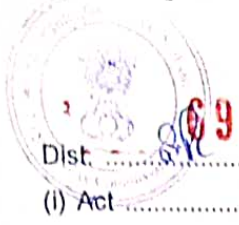

Subject: Written Complaint

Respected Sir,

I, Jagadish Singh @ Parmeshwar Singh, son of late Baig Nath Singh aged about 77 years, resident of Nibedita Road, Pradhan Nagar, Ward No. 3 of SMC, P.O & P.S Pradhan Nagar, Dist. Darjeeling, West Bengal 734003 would like to inform you as follows:

1) That since last month my younger son Binay Singh along with one Rinki Chatterjee have been consistently following me and demanding big some of money along with shares in all the personal properties recorded in my name and as well as in my wife's name 'Sunaina Devi' and when I denied to him peacefully to give any money or share in our personal properties, he started randomly arriving at our doors and abuse us in loud and hurling voices using all kinds of filthy languages and passing indecent comment on us.

2) That two weeks ago out of nowhere, Binay Singh along with Rinki Chatterjee break down into our house by kicking the main gate and thereafter Binay Singh banged my office doors and entering into my office he first got hold of my collar and then took out his gun threatening me pointing it on my head and on the gun point he and Rinki Chatterjee extorted all the money I had along with the property papers, deeds, share certificates and most importantly my will which I

kept secretly in my office and he also took other valuable securities which are recorded in my name and in my wife's name.

3) That with the help of the afore-said documents as extorted by Binay Singh and Rinki Chatterjee, they have already re-manufactured, prepared and procured false, fabricated and forged deeds, documents and false copies of my other valuable securities and have ~~so~~ dishonestly transferred and sold my vehicles, machineries and other valuable securities with intention to cheat and deceive me and earn from its proceeds wrongful gain to ~~my~~ huge wrongful loss to my property and reputation and because of which a huge number of liabilities are now standing in my name.

4) That Binay Singh along with Rinki Chatterjee lives in a separate place at Nivedita Road, near Ratan Motorcycle workshop, P.O & P.S Pradhan Nagar but on 28/06/2022 again they forcibly entered into our main gate and started banging our doors with kicks and other tools and out of fear when we requested them not to trouble us in our old age, they broke the lock of our house door and forcibly entered into it threatening us that they will throw us out of the house and will take over all our property by hook and crook.

5) That again on 05/07/2022 Rinki Chatterjee threatened me stating that she has good hold amongst some lady's group with the help of whom she will falsely implicate allegation of rape against me and will destroy my image and reputation in the locality. She also warned me with dire consequences that she will not let me and my wife to stay anymore

in our own house and will make sure that our health condition degrades day by day by their torture and harassment.

6) That aforesaid persons have warned me that in case I try to intimate or report the above matter to any other person or seek any help of the law enforcement agencies, then they will go to any extent for ruining our life and take our property.

I and my wife ^{are} old ailing senior citizens and heart patient who are expecting to live remaining few years of our life with peace but due to the aforesaid persons our life is in extreme risk and danger and which has adversely affected our health condition.

It is my humble and sincere request to you to look into this matter at the earliest in order to save our life, and property from the tricks and tantrums of the said Binay Singh and Rinki Chatterjee and to take immediate and necessary actions against them and charge them under relevant laws of the land.
