It was intolerable for me to live there in his house in Kolkata, Ballygunge. so I decided to come back.

Before marriage it was told by them that they are against dowry and they don't want it. I was told to do a job and support the family. I started working but still the torture continued. I was bearing all the expenses of the house and he also used to ask to me tell my parents to send money. I never told them since my parents are old and I always gave him the money. I was trying to compromise and continue this relationship all these years bearing all the sufferings. But it was unbearable and I decide to come back. But today i.e. 9/6/2022 Devesh and his father Mr. Sashikant Doshi arrived<sup>to</sup> my parents house and knocked and forced them to send me back and also asked for money. They arrived at my parents house at 7:30 am. I was not at home that moment as I was out for morning walk.


Regarding this matter that I cannot continue this relationship I had told them over phone call and will work out legally eventhough today they arrived
