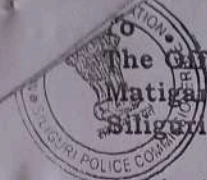

Subject: F.I.R

Sir,

With due respect and in producing herewith the arrested accused person namely Amir Bara (29 yrs) S/O Late Samel Bara of Rana Busty, PS- Matigara, Dist.- Darjeeling with following articles under seizure :-

- (i) One Truck (Shaktiman) bearing Reg. No. WB/73/C/1577 loaded with River bed materials.

I, SI Goutam Mallik of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person namely Amir Bara (29 yrs) S/O Late Samel Bara of Rana Busty, PS- Matigara, Dist.- Darjeeling to the effect that in the night of 11.07.2022 at 23.05 hrs I received a secret source Information that one Shaktiman Truck loaded with River bed materials standing at Balasan River bed, Rana Nagar near Basanti Ghat without any valid documents. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 585 dated 11.07.22 and informed the fact to Officer In Charge, Matigara PS and as per his kind direction myself along with force had been to Balasan River bed, Rana Nagar near Basanti Ghat Under PS Matigara, Dist Darjeeling to work out the information in hand. After arrival of the spot, I found one Shaktiman Truck displaying number plate WB/73/C/1577 loaded with River bed materials standing at Balasan River bed, Rana Nagar near Basanti Ghat Under PS - Matigara, Dist Darjeeling and also found the driver of the vehicle is seating in the driver seat. On being asked he disclosed his identity as the driver of the said vehicle and also disclosed his name & address as noted above. On demand he failed to produce any valid documents in respect of river bed materials loaded in his vehicle. On further interrogation he admitted his guilt and stated that he mines such river bed materials from Balason river by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle having number WB/73/C/1577 loaded with illegally mining river bed materials under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Amir Bara (29 yrs) S/O Late Samel Bara of Rana Busty, PS- Matigara, Dist.- Darjeeling and arrange for its investigation.
