Respected Sir,

I KIRAN CHOUDHARY, wife of Shri Ram Dayal Choudhary, resident of Santoshinagar, Siliguri want to inform you that on Sunday 10/7/2022, in the afternoon at around 3.30 pm my neighbour pramodroy's tenants (name unknown) entered our home as thieves through rooftop. They came through that way to steal and commit burglary as they thought we were not there. When I heard some noise coming from the rooftop I ran to see who is creating the mess all around my roof. Both of my daughters also came along. As soon as I came a man one of the suspect and tenant of Pramod Rai tried to run when he saw me coming towards him. In the meantime when I tried to catch him he attacked us with kicks and blows. He also sexually assaulted & abused me & my daughters. When I tried to defend and protect my daughters he kicked me in my stomach, and also slapped one of my daughters Rabina Choudhary. After that he climbed back my rooftop wall and jumped back in his area rooftop. All the tenants of Pramod Rai including his daughter & other men and women around 15 people, then suddenly gathered in front of my main gate with iron rods, bamboo, wooden bats, broken glass bottles and knives to attack us. Soon lots of people and neighbours also gathered at my gate. All of them just remained mute and spectators, no one stopped them. When I asked them why did they trespassed my boundary wall and came on my rooftop, they kept on abusing and hitting my main gate with rods and pushing it frequently to break it and enter my house. They constantly provoked us by filthy language and challenging us to fight. Pramod Rai the main culprit came near my main gate and touched me and my daughters inappropriately. He attacked us many times with wooden bats and so we were forced to come back in our house. I asked him to keep a distance but he kept on abusing like he will kill us all. Soon after when my son Ravi Kiran came back home, Pramod Rai instantly held him by his hand & attacked him and tried to thrash him with wooden bats. They also attacked my husband as soon as he came back home.

There is a tree nearby in their home, most of whose branches fall within our boundary rooftop. Earlier also the tenants of Pramod Rai have trespassed my boundary wall and have come on my rooftop through that tree. They try to watch my daughters while bathing or doing any private things. Pramod Rai's

tenant in the direction of Pramod rai have earlier many times attempted to commit burglary in my home by trespassing. Many times we have also seen them doing toilet on our boundary wall. I would like to mention here that as per our previous complaint dated 29/4/2021 we have already stated that on the left side of our boundary wall is the land of Pramod roy S/O Chandreswar Roy resident of Santoshinagar, Siliguri have done illegal construction attached to our boundary wall without leaving any space and toilet attached without tank, the complain of which was also handed over to SMC & Borough Office. Last year in one such incident he also broke our drainage pipe. I would also like to mention here that they have been using our wall which is between our house and often drive nails into our wall. When we tell them not to do so they start abusing and threatening us. We have warned them many times. Due to this continuous threatening by all those miscreants we have installed 2 CCTV cameras near the gate. My son has also recorded some of the incidents of their abuse. Pramod rai along with his tenants has threatened my whole family that they will not let us go out for our work and beat us to death or attempt to murder. He has threatened my daughter arti dayal that they will abuse her and molest her when they find her out. Due to their continuous violent behaviour, abusing, threatening, me and my younger daughter often fall ill. We are unable to reside at our home with peace. We are constantly in fear due to all these. Pramod Rai along with his tenants and neighbours often plan conspiracy against my family so that our peace can be destroyed. They are all jealous of my family because we don't indulge with outside people and just remain busy within our home. They often find reasons, ways and means to fight with us. They keep on harassing us with so many things from many years. Day by day they are taking the form of hooligans and constantly keep on abusing us. Now the things have gone out of control. We have complained many times against Pramod Rai & his tenants but all in vain. I can identify all his tenants if brought before me. Pramod rai is a very dangerous person and an anti-social element. He is into hooliganism and other illegal anti-social crime things.

Therefore I request you to kindly register my FIR & take the necessary legal action for our protection. I also declare that if any untoward incident happens with me or my family anywhere, then only Pramod rai & his tenants, their whole family should be held responsible.
