

Sir.

With due respect and in producing herewith the arrested accused person namely Amit Sawria (33 years), \$/O Nirmal Sawria of Fulbari Patan, PS - Matigara, Dist-Darjeeling with following selzed articles:-

One vehicle Tractor having Reg. No. WB - 73 A/9968 loaded with River bed materials.

I, SI Paresh Barman of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 15.07.2022 at about 06:05 hrs onwards I received a secret source Information that one vehicle loaded with River bed materials standing at New Chumta without any valid documents. Accordingly I inform the fact to Officer In charge, Matigara PS and as per his kind direction myself along with force had been to New Chumta under PS Matigara Dist Darjeeling to work out the information in hand. After arrival of the spot I found said vehicle Tractor having Reg. No. WB – 73 A/9968 loaded with River bed materials standing at Panchkelguri under Matigara PS area. Accordingly, I apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials leaded in his vehicle. On further interrogation he stated that he mines such river bed materials from Patan Fulbari Ghat by illegal means with a view to sell the same for his illegal gain. Accordingly I seized the above noted vehicle leaded with illegally mining river bed materials under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Amit Sawria (33 years), S/O Nirmal Sawria of Fulbari Patan, PS – Matigara, Dist- Darjeeling or the owner of the vehicle and arrange for its investigation.
