I Sri Saugat Badhawan, son of Late Bananashi Badhawan, resident of C/o Sri Ramjee Sha near Baptist church P.O. Solbari P.S. Pradhan Nagar Dist. Darjeeling, Pin-734002 do hereby inform you that Sri Kajal Mahanta, son of Late Neependra Nath Mahanta, permanent resident of Vill Jotgopal, P.O Thakurpura, P.S. Baluaghata, Dist Dakshin Dinajpur, Pin-733145, at present residing at Bagha Tatin Colony, Road No 11, Ward No 45 of Silliguri Municipal Corporation, P.O & P.S. Pradhan Nagar, Dist Darjeeling Pin-734003, the due holder of Driving Licence bearing No. NB-6120030022642, valid till 02.11.2023, On September 2020 entered into a verbal agreement for plying my vehicle (Swift Dzirey DI) bearing no NB 7308293. It is to mention here that at that time he was in receipt of Rs. 240,000/- (Rupees Two lakh Forty thousand) only due from me, with a condition that the amount shall be deducted for Rs 20,000/- per month.

And as per the verbal agreement the aforesaid amount was cleared on August 2021, After that I went to him and asked to return my aforesaid vehicle on which he said that I need some time 2 months to return the said vehicle. On his assurance I come back and waited for some on the month of October 2021 I went to him for my vehicle but instead of returning my vehicle he didn't allow me to see the vehicle nor allowed to enter his house on asking he said that he will not return the vehicle and threatened me with dire consequences and told me that if I ever ask anything about the vehicle than he will kill me and my family members. So that he could do anything to danger my life as he is such criminal minded person of the society. After hearing such things I got afraid and somehow manage to escape from there. As I was very much afraid never get guts to visit his house again. But till now instead of returning my aforesaid vehicle he used to threatened me by saying to forget about the vehicle coz he is not going to return it and If I will disturb him again than he ^{will} kill me and will destroy my vehicle as well.

Sir I am a very poor person and have the
only source of in my vehicle and I couldn't
paid my houserent and maintain my family.
and he is a very dangerous and despotistic in nature
having no respect for law.

So therefore I request you to kindly look
into the matter and save me from this person
and help me to recover my vehicle from
his custody I would be ever grateful to
you.
