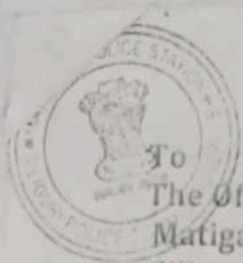

Under information and kind order of O/C Matigara P.S on arrival at New Chumta under Matigara P.S area, I found one vehicle bearing Reg. No. WB - 73 E 0412 loaded with river bed materials going towards Matigara area Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area. As such I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought to the above noted bricks at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle and the seized vehicle under proper section of law and arrange for its investigation.
