l, ASI Tarun Kanti Ghosh of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Rakesh Paul (40) S/O Lt. Anil Paul , of Santi Kuthi Club, Shyama Prasad pally ,Gunjibari PS- Kotwali Dist- Coochbehar to the effect that on 16.07.22 at 22.15 hrs. Myself along with force CV/992 Jagadish Biswas, CV 223 Swapan Chettri left for Night patrolling duty, vide PDN PS GDE No. 954 DTD.16.07.22 ,During patrolling 1 received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his shop at Uttar Mallguri,near Regulated Market gate No.1. Accordingly the fact is informed to you and as per your kind direction myself along with force left for Uttar Mallguri ,near Regulated market under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the shop where he kept illegal alcohol. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his shop in conceal position. On searching found 15 (Fifteen) Plastic bottles of Himalayan Gold, Country Spirit, 60\* up each bottle containing 600 ML.On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since long for his wrongful gain. Accordingly, I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 22:25 hrs to 22.45 hrs. On being asked he stated that he kept the same with a view to sale and supply at Mallaguri area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said illegal beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Rakesh Paul (40) S/O Lt. Anil Paul , of Santi Kuthi Club. Shyama Prasad pally ,Gunjibari PS- Kotwali Dist-Coochbehar, as per proper section of law.
