Sir,

In producing here with the one arrested accused Ajit Halder (33) s/o Bishnupada Halder of Deshbandhu Para, Gopal more, Ram Krishna Sarani, near Bridge, ward no 30 PS- Siliguri Dist- Darjeeling along with Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-)

I ASI Siben Sarkar s/o Raghupada Sarkar of Siliguri PS under Siliguri Police Commissionerate do hereby lodge a written complaint against the arrested accused person namely Ajit Halder (33) s/o Bishnupada Halder of Deshbandhu Para, Gopal more, Ram Krishna Sarani, near Bridge, ward no 30 PS- Siliguri Dist- Darjeeling to the effect that on 16/11/2022 during Special Drive duty (vide Siliguri PS GDE no 1017 dated 16/07/2022) I received a source information at about 16.05 hrs from Deshbandhu Para, Ram Krishna Sarani, Gopal more, ward no 30 under Siliguri PS, that one Ajit Halder is selling huge quantity of liquor illegally in his house to his design customers since long, for his wrongful gain. After sharing the information with I/C Siliguri and as per his kind direction, I along with ASI Debasish Das, ASI Rabin Lama, LC 1282 Swastika Sharma, CV/263 Prasenjit Dey accompany with PSI Sumit Rawat proceeded to the P.O to work out the source information. At about 16.15 hrs I along with my accompanied police team reached at Deshbandhu Para, Gopal more ward no 30 and on being identified by the source our police team held raid in the house of Ajit Halder, after seeing the police team said person tried to flee away but we managed to apprehended the said person, and recovered Eleven (11) sealed bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, which was laying under the bed,. On interrogation he disclosed his identity as Ajit Halder (33) s/o Bishnupada Halder of Deshbandhu Para, Gopal more, Ram Krishna Sarani, near Bridge, ward no 30 PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor. accordingly I seized the same viz: Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-) from the possession of Ajit Halder (33) s/o Bishnupada Halder of Deshbandhu Para, Gopal more, Ram Krishna Sarani, near Bridge, ward no 30 PS- Siliguri Dist- Darjeeling (seizure and labelled was made between 16.30 hrs to 16.55 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Ajit Halder (33) s/o Bishnupada Halder of Deshbandhu Para, Gopal more, Ram Krishna Sarani, near Bridge, ward no 30 PS- Siliguri Dist- Darjeeling under proper section of law.
