Sir,

In producing here with the one arrested accused Bikram Das @ Munna Das (22) s/o Manoranjan Das of Rabindra Nagar near Girls School ward no 21 PS- Siliguri Dist- Darjeeling along with Eleven (12) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 12 = Rs1440/-)

I ASI Rabin Lama s/o Birendra Kumar lama of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Bikram Das @ Munna Das (22) s/o Manoranjan Das of Rabindra Nagar near Girls School ward no 21 PS- Siliguri Dist- Darjeeling to the effect that on 16/11/2022 during Special Drive duty (vide Siliguri PS GDE no 1017 dated 16/07/2022) I received a source information at about 19.05 hrs from Rabindra Nagar, ward no 21 under Siliguri PS, that one Bikram Das @ Munna is selling huge quantity of liquor illegally in his house to his design customers since long, for his wrongful gain. After sharing the information with I/C Siliguri PS and as per his kind direction, I along with, ASI Siben Sarkar, ASI Debasish Das, CV/263 Prasenjit Dey proceeded to the P.O to work out the source information. At about 19.20 hrs I along with my accompanied police team reached at Rabindra nagar ward no 21 on being identified by the source our police team held raid in the house of Bikram Das @ Munna Das, and we managed to apprehended the said person, and recovered Twelve (12) sealed bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml. On interrogation he disclosed his identity as Bikram Das @ Munna Das (22) s/o Manoranjan Das of Rabindra Nagar near Girls School ward no 21 PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz: Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 12 = Rs1440/-) from the possession of Bikram Das @ Munna Das (22) s/o Manoranjan Das of Rabindra Nagar near Girls School ward no 21 PS- Siliguri Dist- Darjeeling (seizure and labelled was made between 19.35 hrs to 20.10 hrs) in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Bikram Das @ Munna Das (22) s/o Manoranjan Das of Rabindra Nagar near Girls School ward no 21 PS- Siliguri Dist- Darjeeling under proper section of law.


