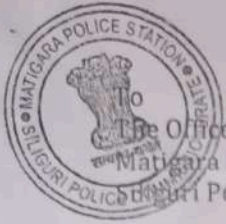

In producing herewith one seized vehicle bearing no. WB-73-A 0001 loaded with stone chips (river bed materials) under proper seizure.

I, PSI Agen Lepcha of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against above noted to the effect that today on 16/07/2022 at 21:35 hrs while performing mobile van duty myself along with Const- 374- Devraj Biswas & Constable-219 Sanatan Chitrakar one vehicle bearing no. WB-73-A-0001 being loaded with river bed materials at Balasan river bed at Balasan Ghat under Matigara PS but the driver of the said vehicle, carrying of river bed materials by illegal means for his wrongful gain, managed to flee away from the spot leaving the vehicle as an abandoned. Subsequently I seized the vehicle bearing registration no. WB-73-A-0001 loaded with stone chips (river bed materials) presence of available local witnesses following all formalities. The whole process of seizure made in between 22:40hrs to 23:25hrs on 16.07.2022.

Hence, I pray that a specific case may kindly be started against the above noted vehicle bearing registration no. WB-73-A-0001 and its driver as well as owner under proper section of Law and arrange for its investigation.
