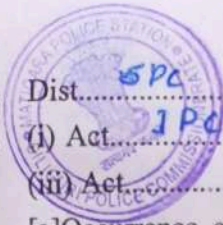



doctor and staff and wrong treatment of my mother

Sir, I am Anirban Das, Father Name - Bakul chandra Das,
of Paschim Jharbelpali, P.O. - Beltali Bhandari, P.S. + Block-
Falakata, Dist. - Alipurduar, pin - 735211. is stating that my
mother ^{chandana Pal Das (56y)} was admitted in North Bengal Medical college and
^{female ward 1 (Bed no. 71)} Hospital from 8th July, 2022. Since then no proper medical
care was taken for my mother, instead the hospital staff
including the senior doctor and intern were misbehaving
with us. Last night they gave her an injection without do-
ing the kidney dialysis which led to her death. After
that the intern doctor and nurses started misbehaving
with us, which we have already prove in a
video. Dear Sir I request you to take proper action
against NBMCH staff involved in harassing us and
death of my mother.

We suspect that the 2nd blood unit which was given was expired. We request you to do a proper post mortem and give us the report so that we can take action. Around there was an injection pushed in her left hand after which my mother expired. The same doctor tried to hit me in the morning when I ask what injection did he pushed.
