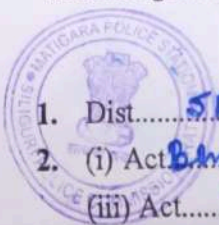

Sir,

In producing herewith one accused person named Shaliya Sahani (50 yrs) W/O Lt. Sonelal Sahani of Tulsinagar, Kholaibhaktari PS- Matigara, Dist- Darjeeling along with following articles under proper seizure list. The ground of arrest duly been communicated with her.

(i) 14 (Fourteen) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 MI in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

I, PSI Shekhar Adhikary of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Shaliya Sahani (50 yrs) W/O Lt. Sonelal of Tulsinagar, Kholaibhaktari PS- Matigara, Dist- Darjeeling to the effect that on 16/07/2022 at 18:40 hrs received a source information that one lady named Shaliya Sahani (50 yrs) W/O Lt. Sonelal of Tulsinagar, Kholaibhaktari PS- Matigara, Dist- Darjeeling is selling liquor at her residence without any valid license. Accordingly the fact was diarized in General Diary vide Matigara PS GDE No 838 Dated 16/07/2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to the house of the above noted accused to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of accused Shaliya Sahani (50 yrs) W/O Lt. Sonelal of Tulsinagar, Kholaibhaktari PS- Matigara, Dist- Darjeeling and managed to apprehend her. On being asked she disclosed her identity as noted above and disclosed that she is selling illicit liquor at her residence without any license for her wrongful gain. Further being searched the above noted seized articles were recovered from the house of the said accused. On demand she failed to produce any valid license/papers for selling and storing of such articles. On further interrogation she stated that she is involved in selling and possessing of liquor without any valid license for last few months for her illegal gain. Then, I seized and labelled the above mentioned liquor under proper seizure list and arrested the above mentioned lady named Shaliya Sahani (50 yrs) W/O Lt. Sonelal of Tulsinagar, Kholaibhaktari PS- Matigara, Dist- Darjeeling with the help of lady force and keeping decency, after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 16/07/22 in between 19:30 hrs to 20:10 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused Shaliya Sahani (50 yrs) W/O Lt. Sonelal of Tulsinagar, Kholaibhaktari PS- Matigara, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
