With due respect I the undersigned would like to inform you that I had entered into the marriage with Sri Snehangshu Ghosh, S/o. Sri Jiban Ghosh, of Fire Brigade Road, Khalpara, P.O. – Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling and said marriage was solemnized on 02.03.2012 according to Hindu Rites and Customs in my paternal house at Netaji Colony, Ghogomali, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri.

I would like to further inform you that at the time of the said marriage as per demand of my husband, my father-in-law Sri Jiban Ghosh, my mother-in-law Smt. Snehalata Ghosh, my father had paid a sum of Rs. 70,000/- (Rupees Seventy Thousand) only in cash for arranging the reception (Boubhat) and also had given valuable furniture, gold ornaments, house hold articles etc. to them. After the said marriage I was brought by my husband in my matrimonial house along with the said valuable articles and I had entrusted the same to my husband and my said in-laws and we started to reside there in the joint mess as husband and wife. Out of the said wedlock I gave birth of a female child on 14-07-2015.

I would like to further inform you that after the birth of the said new born baby my husband along with my said in-laws and my one married sister-in-law Smt. Moumita Ghosh, W/o. Sri Bijoy Ghosh of Airport More, Bagdogra have started to misbehave with me due to the birth of my said female child and my husband and my in-laws clearly expressed that they would not accept the female child as because they wanted a male child who would take the responsibility after getting the majority. At the relevant time my husband and in-laws neglected to maintain me properly even also refused to give the proper food to me at the stage of post pregnancy and they also refused to provide the milk and other food and medication to my said minor daughter and on one occasion my mother-in-law with the help of my sister-in-law put the salt on the mouth of my said baby with an intention to kill her but somehow I managed to save her life with my utmost effort. I would like to further inform you that one occasion I found some vulgar messages in the whatsapp of my husband and I found from there that my husband was maintaining the illicit relation with cousin sister Smt. Banhi Sikha Ghosh and getting the said sapinda relation, I vehemently protested the same to my husband and due to such protest, my husband and my father in-law assaulted me mercilessly and get the ultimatum not to disclose the matter to anybody otherwise they will not hesitate to hang me with my said minor. But being a prudent woman having my own dignity, I could not resist me myself and I took the probable measure to stop such barbaric act and I informed the same to my relatives and well wishers and during a meeting as called for in my matrimonial house, my husband confessed the same and tendered the apology with a promised to stop the said relation further and I heard that the matrimonial relation between said Smt. Banhi Sikha Ghosh and her husband was dissolved way of decree of divorce.

I would like to further inform you that after the said discloser regarding the prohibited relation in the society of my husband, he has decided to ruin my matrimonial relation and he expressed the same on one occasion in intoxicated condition and gradually he stop my all sort of maintenance and my minor daughter and he again started to maintain and another extra marital relation for giving me a lesson and whenever I tried to resist him, he along with his parents assault me brutally and for taking the revenge my husband sometime assaulted me and compelled me to give some vulgar deposition as per his desire and he recorded the same in his mobile device and he also took some my nude photographs in his mobile and same has been edited with some male persons and he started to blackmail me by saying that if I will try to resist him to maintain the extra marital relation and also ask for my maintenance and for my minor daughter, he will expose the same in the social media and throw out me from my matrimonial house with my minor daughter.

I would like to further inform you that from the very inception of the said torture as made by my husband and in-laws, I tried to swallow the same considering the better future of my minor daughter and moreover my parents are not in a position to maintain me and my minor daughter due to their financial hardship and I could not take any legal step against them and taking the said advantage they all have continued their torture upon me and today in the evening my parents-in-law assaulted me just without any reasonable cause and tried to oust me and my minor daughter from my matrimonial

use and I tried to inform the same to my husband but he refused to receive my phone call and I have no other option but to lodge this complaint with the humble prayer to investigate the matter and do needful for the ends of justice.
