Respected Sir,

I, Smt. Moumita Mahanta, Daughter of Sri Bipul Mahanta, Permanent resident of Near Dakshin Kuaran Shikha Kandra, Kuaran, Dist.- Dakshin Dinajpur, presently residing at Surya Sen Pally, Shivmandir, P.O.- Kadamtala, P.S.- Matigara, Dist.- Darjeeling, would like to lodge this complaint that on 08.03.2021, a Hindu marriage was solemnized in between myself and Sri Mridul Chakraborty, Son of Sri Milan Chakraborty, resident of Hider Para, New Pal Para, in front of Sree Chaitanya Math, P.O.- Hider Para, P.S.- Bhaktinagar, Dist.- Jalpaiguri, following Hindu rites, rituals and customs and our marriage was arranged one.

After ending of Boubhat ceremony, my sister-in-law viz. Malati Chakraborty has forcibly compelled me to open my all gold ornaments from my body and thereafter taken away the full custody of all those gold ornaments given by my parents.

At the time of marriage, my parents have given more than 5 Bharis of Gold Ornaments and cash Rs.- 1,50,000/- (Rupees One Lac Fifty Thousand) only to my in-laws, as per demand made by my in laws especially my grandfather-in-law viz. Baidya Nath Chakraborty and my parents also made other huge expenditure of near about Rs. 5,00,000/- for my marriage.

Sir, from the next day of my marriage, my husband viz. Mridul Chakraborty, my mother-in-law viz. Smt. Arati Chakraborty, my father-in-law viz. Sri Milan Chakraborty and my sister-in-law viz. Malati Chakraborty started creating unbearable tortures upon me for bringing cash monies of Rs. 2,00,000/- (Rupees Two Lac) only as further dowry from my parents, but initially when I told them that my father is a poor person, then my sister-in-law and my husband started assaulting me mercilessly by catching my hair and also kicked in my abdomen portion.

Sir, lastly without tolerating their unbearable tortures, I was compelled to call my mother and told her to give at least a sum of Rs. 1,00,000/- (Rupees One Lac) only to my husband, otherwise, they will kill me and then my mother has given further a sum of Rs. 1,00,000/- (Rupees One Lac) only to my husband for saving my life, after taking loan from several persons.

Sir, after lapse of 4 to 5 days of taking money, all my aforesaid in-laws started taunting me and also started creating undue mental and physical tortures upon me by asking more money as dowry.

Sir, my husband is a habitual drunker and on several occasions, he forced me to take alcohol and also forced me to spend night with his friends and when I have denied, then my

husband and sister-in-law started assaulting me by fists, kicks and blows and in this way, within a span of 3 to 4 month I have experienced with the hell life, due to their intolerable and merciless mental and physical continuous tortures upon me and on several occasions, all my in-laws have instigated me to commit suicide.

Sir, in the month of December, 2021, I came to know that my sister-in-law and husband, in collusion and in connivance with also other in-laws, have illegally sold out my said 5 Bhari of Gold Ornaments, keeping me in dark and they have dishonestly misappropriated near about a sum of Rs. 3,00,000/- (Rupees Three lac) only including earlier paid amount of Rs. 2,50,000/- (Rupees Two Lac Fifty Thousand) only i.e. altogether a sum of Rs. 5,50,000/- (Rupees Five Lac Fifty Thousand) only for their illegal and malafide gain and practically, my all aforesaid in-laws have cheated myself and my poor parents.

Sir, lastly on 12.07.2022, all the aforesaid persons have started beating me for bringing more cash money from my parents and when I refused, then my sister-in-law viz. Malati Chakraborty strangulate in my throat with an intention to kill me and immediately thereafter my husband took a pillow on my mouth for killing me and somehow, I was able to rescue myself from their evil hands and thereafter in my wearing apparels, they have driven out myself from my matrimonial house.

Sir, afterthat my parents have tried their level best to reunite our relation and matrimonial tie from all corners as my parents are very poor and they cannot arrange my further marriage, after spending all their more in my marriage, but on 17.07.2022, my aforesaid in-laws have clearly denied to take myself without atleast a further a sum of Rs. 5,00,000/- (Rupees Five Lac) only.

I, therefore, requesting you to take an immediate drastic actions against my husband viz. **Sri Mridul Chakraborty**, my mother-in-law viz. **Smt. Arati Chakraborty**, my father-in-law viz. **Sri Milan Chakraborty** and my sister-in-law viz. **Smt. Malati Chakraborty** in accordance with law and your good office and urgent co-operation is very much expected in this regard.


