This is to state that I, i.e. Tuhin Majumdar resident of Sukantapally Siliguri, Ward no. 32, have been scammed by online scammers today.

On 15/07/22 I dialed 198 for complaint registration at airtel customer care regarding a online transaction of 301 ₹ which I made on 03/07/22 but it was unsuccessful. The customer care executive assured that I would receive the amount within 7-10 days since it was deducted from my bank account.

Today <sup>i.e. 17/07/22</sup> ~~morning~~ morning, I received a phone call from the number 07368990388. The person on the other side told me that he is airtel customer care executive and I would get the refund amount instantly if I follow some process. He then told me to install "Team Viewer Quick Support" app. After that he told me to open Airtel Thanks app. Then to open "Scan any QR" from the Bank profile from Airtel Payments Bank. Then he told me to scan my SBI-Debit card both side. Just a few moments later around 9.40 AM money started deducting from my bank account. Then I disconnected the call and block my card by yono app. But within those moments an amount of approx. <sup>70261.49</sup> ~~70000~~ INR was deducted. After that I tried to call cyber crime via phone but my call was not
