

Sub: Complaint against my husband Sanjit Sharma, Son of Kailash Sharma and others, residing at Champasari, Ward No.46 of S.M.C., P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling.

Respected Sir,

I, **Smt. Sunita Sharma**, Wife of Sri Sanjit Sharma and daughter of Sri Ganesh Sharma, residing in my parental home at Ektiasal Haat, Isckon Mandir Road, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my husband **Sanjit Sharma**, Son of Kailash Sharma and others, residing at Champasari, Ward No.46 of S.M.C., P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, to the effect as follows:-

- 1) That it is pertinent to mention here that on 24-09-2021, I had lodged a complaint against my said husband, my in-laws and one lady who is the second wife of my husband with the Inspector-in-Charge, Pradhan Nagar Police Station for subjecting me cruelty and marriage again by my husband during my lifetime and on the strength of my complaint, the Pradhan P.S. started a specific case against them vide Pradhan Nagar P.S. Case No.777/2021, under Section 498A/494 of IPC and the same is pending before the Ld. A.C.J.M., Siliguri and due to the aforesaid incident, I have been residing at my parental house with my two minor children.
- 2) That in my name, my father along with my brother have purchased a vest land measuring 1 Katha 13 Chhataks, together with tin shed residential pucca house, having one bed room and one kitchen standing on the said land, situated within Pargana- Patharghata, under Mouza- Daknikata, Police Station- Pradhan Nagar, B.L. & L.R.O. office- Matigara, District- Darjeeling, J.L. No. 83(105), Touzi No.91, comprised in part of Plot No.169, within the limits of Ward No.46 of Siliguri Municipal Corporation and my said house is surrounded by concrete wall with an fixed iron gate and the same is under my possession and the said entrance gate and door of the house was under lock and key by me.
- 3) That on 13-07-2022 at about 10:00 PM to 10:30 PM, husband said Sanjit Sharma along with his friends under the influence of alcohol broke lock pads of the entrance gate and door of my house and criminally trespassed into my house and started drinking alcohol in my said house and when I got the information of the same from some local people, I along with my



brother went over there, seeing me and my brother, my husband mentally tortured me by abusing me and my brother in most decent and filthy languages and threatened me and my brother of causing grievous injuries upon us but due to help of some local people, I along with my brother somehow managed to oust them but my husband open threatened me and my brother that he will again come therein and again will break the lock pad of the gate and the door of my house and there will be non to stop him.

- 4) That my husband is desperate in nature and dangerous person having no regard of the law of the land.

So, therefore, I humbly request you take necessary legal action against my husband and booked him under specific provision of law.
