I, Sri Arbind Kumar Son of Lt. Jai Narayan Yadav, resident of Kolkata Road, near Air force office, Bhujiapani, Police station Bagdogra District – Darjeeling would like to inform you and for your kind information and necessary legal actions as following facts:

1. That I had a Partnership Business with one Partner namely Smt. Suleka Yadav, wife of Sri Indra Dev Yadav, resident of Betgara, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri. And said business was started name & style as **M/S Jai Dharamraj Enterprise** in the year 2018 nature of business General Order Supplier, its present office at Betgara, Jungle Mahal P.O. Salugara, P.S. Bhaktinagar Dist. Jalpaiguri
2. That my business partner i.e., Smt. Suleka Yadav, wife of Sri Indra Dev Yadav has approached to me for more investment for more profit and for that purpose taken loan for business expend and I had been invest huge money and also taken loan from different financial institutions and from my friends and my well wishers for said partnership business.
4. That during the period of our business said partner has approached to me for purchase a new car which will help us for marketing and accordingly I have purchased a car Maruti Suzuki Swift dzire On 13th Aug 2020 in the name of our partnership firm.
5. That the our partnership business was running peaceful till the month of Nov 2021, but when our business was closed then I had been seen that my partner Smt. Suleka Yadav, and his husband Indra Dev Yadav and his son namely Sanjiv Kumar Yadav was started torture and threatened me regularly for transfer the vehicle bearing registration No. **WB74BC 7291** in her name and his son namely Sanjiv Kumar Yadav also violently attacked me and restrained me different time lastly on 18.04.2022 in front of Radio centre Sevoke Road Near Radio Centre they are accompanied restrained me and my Partner Smt. Sulekha Yadav had given to me one blank cheque A/c Payee against my Account. She was taken from me said Rs. 15,00,000/2 (Rupees fifteen lakh) and

physically assaults me and also threatened me with dire consequences and when I asked about their this type behaviors then they says we shall kill you no body can help you, this is our area.

7. That my partner Smt. Suleka Yadav had taken possession the said vehicle and she and her husband and her son regularly threatened me with dire consequences and it clear from their act they have deep rooted conspiracy and cheating me and deceived me and they are already started to abuse me with filthy languages and threaten me with dire consequences.

I therefore request you kindly enquire the matter and arrest the accused namely Smt. Suleka Yadav, Indra Dev Yadav and sanjiv Kumar Yadav as per provision of law and recover my afore said vehicle from their possession and the above named person taken into custody.
