Respected Sir,

I, Smt. Gulshan Thakur, W/o Manoj Thakur residing at C/o Sakila Begum (Purki) Asraf Nagar, ward no 40 Masjid Road, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to inform you that from the year of 2012 I had a love relation through phone with the above named Manoj Thakur, and since then we decided to marry each other, and he several times induced me to marry me and buildup physical relations with me, every time when I asked him to marry me he said that as it's an inter caste relationship so his family did not accepted our relationship, but finally after several request by my mother he agreed to marry me and finally on 06.06.2016 we got married at Iskon Mandir, P.S. Bhaktinagar, Dist. Jalpaiguri with demand of Rs. 1lack, and as per his dmand my mother somehow manage the same amount and gave him Rs. 1 lack at the time of marriage. Thereafter he took me to his home at Dipalinagar Ward No. 24, P.O Balurghat, P.S. Balurghat, Dakshin Dinajpur. Where almost 2 years I along with my husband stayed there and started my nuptial life, where after few months of our marriage I became pregnant, but hearing the news of this he was started behaving so rude, and one day he gave me one medicine and told me doctor said me to have this medicine before my blood test for pregnancy, and on good faith I took the same but after having the said medicine I became ill and lost my baby. Thereafter he sent me to my sister's rented house at Asrafnagar, as that time my mother was already died. And since then I used to reside with my sister's rented house and my said husband on the regular basis came to my sister house to meet me, and thereafter again two times I became pregnant and he forced me to have medicine to abort my baby. It is pertinent to mentioned that whenever he came to meet me he demanded Rs. 5 thousand from my sister as his travelling allowances, being a poor women it was not always possible for her to give

him so much of money to him, and failing which he used to physically, mentally torture me by various means. On 06.06.2022 my husband came to our another rented residence at c/o khalilur rehman @ babu master of Asraf nagar, ps- bhaktinagar to celebrate our marriage anniversary, where he demanded Rs 50 thousand from my sister, but my sister denied to give him that amount so at midnight he leave our house for Balurghat after doing several physical torture upon me. Thereafter on 11.07.2022 I went to Balurghat with Rs. 20 thousand at my matrimonial house to give him the said amount which was arranged by my sister, after reaching to my matrimonial house. I saw another women who herself said that she is a married wife of the said Manoj Thakur along with two another girl (2 daughters). When I told them that I am also a married wife of said Manoj Thakur, they became so furious and started beating me, and after snatching my purse along with said 20 thousand , gold churi , ear ring they locked me in a room, after several request next day morning they unlocked my room and I somehow manage to escape from their and directly came to Siliguri, and became so ill, thereafter narrated the same to my mother and neighbors, and they all took me to Siliguri Sadar Hospital for my treatment as I was badly assaulted by all of them. Since then I am trying to contact with the said Manoj Thakur over Phone on repeated time but he did not received the same and now his phone is switched off ( phone number of Manoj Thakur 7478121072, 8436074815)

In view of above you are requested to take legal action against all of them as per Law for their illegal acts and activities.
