Sir,

In producing here with the one arrested accused Md Muslim (65) s/o Late Md Siddque of Pran Krishna colony, Tikiapara ward no 28 PS- Siliguri Dist- Darjeeling along with Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-)


I PSI Sumit Rawat s/o Shri Puran Rawat of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Md Muslim (65) s/o Late Md Siddque of Pran Krishna colony, Tikiapara ward no 28 PS- Siliguri Dist- Darjeeling to the effect that on 17/11/2022 during Mobile van duty (vide Siliguri PS GDE no 1106 dated 17/07/2022) I received a source information at about 20.15 hrs from Pran Krishna colony, Tikiapara, ward no 28, under Siliguri PS, that one MD Muslim is selling huge quantity of liquor illegally in his Grocery shop to his design customers since long, for his wrongful gain. After sharing the information with I/C Siliguri PS and as per his kind direction, I along with ASI Debasish Das, ASI Rabin Lama, CV/263 Prosenjit Dey proceeded to the P.O to work out the source information. At about 20.30 hrs I along with my accompanied police team reached at Pran Krishna colony and on being identified by the source our police team held raid in the Grocery shop of MD Muslim, we apprehended the said person, after search the Grocery Shop and recovered Eleven (11) sealed bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml, which was laying under the table. On interrogation he disclosed his identity as Md Muslim (65) s/o Late Md Siddque of Pran Krishna colony, Tikiapara ward no 28 PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz: Eleven (11) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-) from the possession of Md Muslim (65) s/o Late Md Siddque of Pran Krishna colony, Tikiapara ward no 28 PS- Siliguri Dist- Darjeeling seizure and labeled was made between 20.40 hrs to 21.15 hrs in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Md Muslim (65) s/o Late Md Siddque of Pran Krishna colony, Tikiapara ward no 28 PS- Siliguri Dist- Darjeeling under proper section of law.
