Shyam Sunder Roy of above noted address, started abusing me in filthy language and picked up quarrel with me & threatened me for dire consequences if I will demand my ~~share~~ husband's share in the said property.

Sir, it is pertinent to say that, there is a property at Chanopatti, in the name of my mother-in-law namely Lt. Saroj Devi w/o Shyam Sunder Rai and there are three sons & one daughter of my said mother-in-law namely (1) Sanjay Kumar Roy (53) S/O Lt. Shyam Sunder Roy, P/O Kokar Industrial Area, Khatol, Rail + P.O + P.S. Distt-Ranchi (Jharkhand) & (2) Sanjay Kumar Roy S/O Lt. Shyam Sunder Roy, (3) Rakesh Kumar Roy S/O Lt. Shyam Sunder Roy, both are resident of Chanopatti, Near Hotel Sarraj, Ward No. 6 SMC, P.O & P.S.-Siliguri, Distt-Dijauli and (4) Smt. Urmila Singh w/o Sri Hari Nandan Singh, P/O of Vill-Sikandar Pur, Distt-Sivan (Bihar), and after the death of my said mother-in-law, we all ~~became~~ became the legal heirs.

But my said brother-in-law namely Rakesh Kumar Roy is not giving my share and constructed the godown and let it over it & let it out on rent, and when I came from Ranchi to demand my share, he picked up quarrel with me. So, please take necessary action against him.
