Dear Sir.

I, SRI GOURI SHANKAR GOYAL @ AGARWAL, Son of Late Omprakash Agarwal, resident of Agrasen Road, Khalpara, Siliguri, P.O. & P.S. Siliguri, District – Darjeeling would like to bring to your notice the following facts:-

- 1. That I am a Executive Committee Member and immediate past Secretary of Siliguri Merchant Association having its office at Agrasen Road, Khalpara, Siliguri, Near Agrasen Bhawan.
- 2. That today i.e. on 19.07.2022 there was a scheduled emergency meeting at the office of Siliguri Merchant Association and I was also present during the meeting of the same.

That at around 5pm after the conclusion of the meeting, when I came out from the office premises and was ready to leave the premises for my home, suddenly few persons namely Baijnath Rampuria along with Naveen Rampuria @ Monty and others appeared and pushed me and assaulted me and started hitting me with an intention to cause grievous hurt and he further tried to strangle me by my neck and I was at a loss of breath.

That I had around Rs.50,000/-(Rupees Fifty thousand Rupees) and was wearing a gold which ain, and during the said incident the abovenamed person Baijnath Rampuria and Naveen Rampuria snatched the chain from my neck and took all the cash from me and gave it to their associates.

That I had been associated in a meeting to solve a family dispute around 2 months ago and the abovenamed Baijnath Rampuria was too involved in that meeting and dissatisfied with the outcome of the meeting since then have been threatening me over calls over the settlement of that meeting.

- That the same persons over the threathening calls having been using abusive languages and unparliamentarily language and I have been ignoring the same.
- 7. That I have been dealing with these threatening calls since 2 months and even today early morning I received a call during day time threatening me.

- That during the meeting the abovenamed persons gathered near the Balaji Mandir near 8. the office premises and have been planning to surround me and assault me as soon as I come out of the Meeting.
- That after the incident I had to be rushed to the hospital and get the necessary treatment 9. done.
- That if no necessary actions is taken against them I fear they might very threatened they 10. might attack me again and it will be too late to take action further.

That it is therefore prayed that necessary and strict actions is taken against the abovenamed culprits.
