Respected Sir,

I, Sachin Rampuria S/o Baijnath Rampuria residents at Khalpara, Agrasen Road, Ward No 9, Siliguri, Dist Darjeeling, PO and PS Siliguri beg to respectfully say that my father is about 72 years old and today my father Baijnath Rampuria and my brother Navin Rampuria meet to Gauri Shankar Goel at Agrasen road near Siliguri Merchant Association Building at 4 o'clock on date 19/07/2022, that time my father started a conversation with Gauri Shankar Goel about the papers of an old family dispute and on asking for documents from him. On this matter, Gauri Shankar Goel got angry on my father and started abusing my father, he slapped him in front of everyone and his breath got stuck due to strangulation. When my brother came to save my father he push them badly due to push, my father and my brother fall on the road. My father is very old and sick. In this incident my father's gold chain and cash about Rs 8000 fell which we did not get from the place. After that many people come and stop him. Now my father suffered internal injuries in ear, neck, back and leg. Gauri Shankar Goel and his group also threatened my brother and my father that they will not allow us to live in any place of Siliguri and Khalpara. They also bring 4-5 unknown persons for threatening us and also warned us that they killed them. They also gone to my home for threatening us.

So, you are requested to my in view of the above atrocities, take the strict action against the guilty person and I will always be grateful to you.
