Sir,

With due respect and producing herewith one suspected person namely Ayesha Begam (25) female (with one female in her lap) W/O Md. Subhan of Teskuni Para, Khelaghar math Colony, P,S & Dist. Firm gate, Dacca, (Bangladesh) Permanent Address Tamsha Gazibari, Gopal Nagar, PO Debidwar, Dist. Kumillah, (Bangladesh) under arrest. The ground of arrest duly been communicated with him.

I, SI Pranab Kr. Singha of NJP PS, Siliguri Police Commissionerate beg to report that on 13.07.2022 at 07:55 hrs myself along with NVF 0070 Nripen Ray & NVF 0129 Md. Majnu left the PS to perform patrolling duty vide NJP PS GDE No 614 dated 13.07.2022. In course of patrolling duty at 13:30 hrs. I received secret source information that one Bangladeshi National is moving at NJP Railway Station area. Accordingly I informed the fact to the Officer-In-Charge, New Jalpaiguri PS and as per his direction I called L/C-1328, Sangita Male and being accompanied with her had been to NJP Railway Station area. At 13:45 hrs we arrived at NJP Railway Station area and being identified by the source we apprehended above noted female person. On being asked she gave different statement in different time. After prolonged interrogation she disclosed her name as noted above and also disclosed that, she entered into India through border fencing in Benapole sides by illegal way. On demand she failed to produce any valid passport/visa or any documents in support of entry into India from Bangladesh. Accordingly I arrested her (with one female in her lap) and issued memo of arrest and observing all the formalities of arrest and also informed her ground of her arrest. On further interrogation she also disclosed full particulars of her relatives as are 1) Sirajul Islam (father) s/o Abdul Sattar Mia, 2) Jyotsna Begam (mother) w/o Sirajul Islam, 3) Ramjan (brother), 4) Rabiul (brother), 5) Tanjina sister), 6) Abdullah (brother) who are residing at of Teskuni Para, Khelaghar math Colony, P,S & Dist. Firm gate, Dacca, (Bangladesh) Permanent Address Tamsha Gazibari, Gopal Nagar, PO Debidwar, Dist. Kumillah, (Bangladesh).

Under the above fact and circumstances, it is established that the said suspected person entered into this country i.e. India which is restricted for their entry without obtaining permission from the authority, notified by the Central Govt. in official Gazette as well as stay in any area in India without valid documents required for such entry or for such stay.

Therefore, I pray to you that a specific case under proper section of law may kindly be initiated against the arrested suspected person namely Ayesha Begam (25) female (with one female in her lap) W/O Md. Subhan of Teskuni Para, Khelaghar math Colony, P,S & Dist. Firm gate, Dacca, (Bangladesh) Permanent Address, vill.- Tamsha Gazibari, Gopal Nagar, PO Debidwar, Dist. Kumillah, (Bangladesh) and arrange for its investigation.
