Sir,

With due respect, I am producing herewith the arrested accused persons namely (1) Dipak Kumar Samal(34) S/O- Dibakar Samal of khardipur,PS-Binjhar Pur, Dist-Jajpur, Orisa. (2) Shriram Samal(24) S/O- Ghanosam Samal of Do.(3) Bimal Samal(43) S/O- Ganesh Chandra Samal of Do. (4) Shiba Prasad Samal(58) S/O-Lt. Hrudananada Samal of Do. and the following articles under seizure :-

- 1 One 27 inch long strong iron bar used to break locks and Hammer from the possession of accused Dipak Kumar Samal(34) S/O- Dibakar Samal of khardipur,PS-Binjhar Pur, Dist-Jajpur, Orisa.
- 2 One iron made Bhojali from the possession of accused Shriram Samal(24) S/O- Ghanosam Samal of Do.
- 3 One plastic made small charger torch light and one sharp cutting folding knife from the possession of accused Bimal Samal(43) S/O- Ganesh Chandra Samal of Do.
- 4 One plastic made charger torch light from the possession of accused Shiba Prasad Samal(58) S/O-Lt. Hrudananada Samal of khardipur,PS-Binjhar Pur, Dist-Jajpur, Orisa.

1. PSI Pradeep Diyali of NJP PS, Siliguri Police Commissionerate beg to state that on 15.07.21 at 00.45 hrs I received a secret source information that a gang of miscreants come to IOC more under NJP PS area with deadly weapons and assembled there and making preparation for committing dacoity at station and IOC area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No-699 dated 15.07.21. As per kind order and direction of my superior officer myself along with VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy, CV/824 Niru Kumar Yadav left for IOC more to work out the information in hand. I also informed the fact to night RT Van officer and directed him to come at IOC more to accompany with us. At about 01.15 hrs on 15.07.22 we arrived at IOC more. After a few time RT van officer along with force came to IOC more and accompany with us. At about 01.35 hrs we found that 08/09 persons assembled in a dark place at IOC more and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But we the police party managed to apprehended 04 (four) of them and others fled away from the spot by taking the advantages of darkness. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they coming from Orisa had assembled there to commit dacoity in that area. On search I found (i) Dipak Kumar Samal(34) S/O- Dibakar Samal of khardipur,PS-Binjhar Pur, Dist-Jajpur, Orisa. (ii) One iron made Bhojali from the possession of accused Shriram Samal(24) S/O- Ghanosam Samal of Do.(iii) One plastic made small charger torch light and one sharp cutting folding knife from the possession of accused Bimal Samal(43) S/O- Ganesh Chandra Samal of Do. (iv) One plastic made charger torch light from the possession of accused Shiba Prasad Samal(58) S/O-Lt. Hrudananada Samal of khardipur,PS-Binjhar Pur, Dist-Jajpur, Orisa. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity at IOC and station area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted four accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02.35 hrs to 03.15 hrs on 15.07.21.
