Sub:-Misappropriation of Rs. 250000/- by making fraud and cheating and threat with dire consequences by Hari Pada Roy son of late Gutum Singh Roy of village-Sipaipara, P.S.New Jalpaiguri, District-Jalpaiguri

With due honour I Sri Binoy Kumar Das s/o late Ram Chandra Das aged about 75 years resident of Satya Priya Roy Sarani , Nabagram , P.O. Bhaktinagar, Police Station-New Jalpaiguri, District -Jalpaiguri , lodged this complaint to the effect that on 08.08.2016 I entered with an agreement to sell with Sri Hari Pada Roy son of late Gutum Singh Roy of village-Binnaguri Sipaipara , P.O. Sahudangi Hat , P.S. New Jalpaiguri, District-Jalpaiguri in respect of land measuring 02 Kathas appertaining to R.S. Khatian No. 520/3, R.S. Plot No. 133/707, Sheet No- R.S. 11, Mouza-Binnaguri, Pargana-Baikunthapur, Police-Station-New Jalpaiguri (earlier-Bhaktinagar), District-Jalpaiguri at the consideration of Rs. 6,00000/- .

That as per agreement I paid him Rs. 2,50000/- (Rupees Two Lakh & Fifty Thousand) advance on the date of agreement on dated 8.8.2016 in presence of witnesses. That as per agreement it was agreed that within 03 months after taking the rest amount of Rs. 3,50000/- (Rupees Three Lakh Fifty Thousand) he would transfer the land in favour of me. That thereafter several times I requested the said Hari Pada Roy to transfer the above mentioned land in favour of me by taking the rest consideration money of Rs. 3,50000/- (Rupees Three Lakh Fifty Thousand) .That the said Hari Pada Roy day by day falsely assured me to transfer the said land in favour of me but did not comply with the agreement dated 8.8.2016 .

Now on being asked to execute the deed of sale in favour of me in respect of the said land mentioned above ,the said Hari Pada Roy denied to transfer the land mentioned above in favour of me and abused me in filthy languages and threatened me with dire consequences . That the above named Hari Pada Roy by doing fraud & cheating, misappropriated Rs. 2,50000/- (Rupees Two Lakh & Fifty Thousand) which I paid him as advance in respect of sale of his land mentioned above .
