I ASI Biswajit Adhikari of Milanpally out post under NJP PS do here by lodged a written complaint to the effect that today on 16.07.22 at 18:05 hrs acting on a tip-off source information myself along with C/959 Dijen Chandra Roy,C/694 Sushil Saibo, C/980 Sadhan Barman, had been to 18 no Milanpally under Milanpally OP to work out the information that a huge number of country spirit are stocked in the house of one Dinobandhu Malo Das Of 18 no Milanpally, PS- NJP, Dist- Jalpaiguri without license to sale the same in the open market. This refers to Milanpally out post GDE No-425 DT-16.07.22. On arrival at 18 no Milanpally at 18:35 hrs and I called two local witnesses to witness the raid and on being identified by the engaged source we held raid in the house of Dinobandhu Malo Das and could recover the above noted of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquors under proper seizure list and arrested the accused person U/S – 41 Cr.P.C and took him into the custody. The seizure was made in between 19:05 hrs and 19:45 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Dinobandhu Malo Das (59 yrs), S/O- Lt Dabendra Malo Das of 18 no Milanlally, PS-NJP, Dist-Jalpaiguri.
