
Respected Sir,

Champasari, P.S. Pradhan Nagar, Dist - Darjeeling, West Bengal - 734003 with the help of land mafia and antisocial persons making regular attempt to cultivate crops upon my land. Whenever we went to our place of land they assault us with an intention to outrage our modesty. That they are now again doing cultivation work in my land, trying to change the nature and character of the suit land.

So I therefore request before you to kindly look into the matter and do the needful under the provisions of law.
