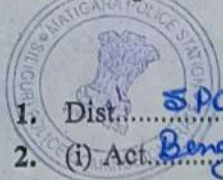

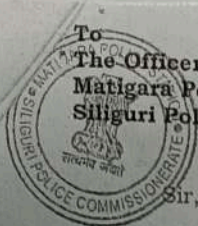

Sir,

In producing herewith one accused person named Mahtab Khan (27 yrs) S/O Bhuttan Ahamed of Vill- Nakaha No-1, PO- Maharipur, PS- Chiluatal, Dist.- Gorokhpur, Uttar Pradesh A/P residing at Darjeeling Truck Line Hotel of Pachkelguri, PS- Matigara, Dist.- Darjeeling along with following articles under proper seizure list. The ground of arrest duly been communicated with him.

- (i) 16 (Sixteen) bottles of 'Himalayan Gold 60 UP' Country Spirit, each bottle containing 600 ML and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".
- (ii) 02 (two) bottles of Mc Dowell's No-1 Reserve whisky containing 750 ML in each bottle marked as "Exhibit- "B" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit B-1".
- (iii) 06 (six) bottles of KINGFISHER STRONG PREMIUM BEER each Bottle containing 650 ML and marked as "Exhibit- "C" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit C-1".


I, SI Uday Chakraborty of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Mahtab Khan (27 yrs) S/O Bhuttan Ahamed of Vill- Nakaha No-1, PO- Maharipur, PS- Chiluatal, Dist.- Gorokhpur, Uttar Pradesh A/P residing at Darjeeling Truck Line Hotel of Pachkelguri, PS- Matigara, Dist.- Darjeeling to the effect that on 21.07.2022 at 17.25 hrs I received a specific source information that one person named Mahtab Khan is selling liquor at his hotel styled as Darjeeling Truck Line Hotel at Pachkelguri, PS- Matigara, Dist.- Darjeeling without any valid license. Accordingly the fact was diarized in General Diary vide Matigara PS GDE No 1123 Dated 21.07.2022 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to Darjeeling Truck Line Hotel of Pachkelguri, PS- Matigara, Dist.- Darjeeling to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at Darjeeling Truck Line Hotel of Pachkelguri, PS- Matigara, Dist.- Darjeeling and managed to apprehended him. On being asked he disclosed his identity as noted above and also disclosed that he is selling illicit liquor at his hotel without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his hotel. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned person named Mahtab Khan (27 yrs) S/O Bhuttan Ahamed of Vill- Nakaha No-1, PO- Maharipur, PS- Chiluatal, Dist.- Gorokhpur, Uttar Pradesh A/P residing at Darjeeling Truck Line Hotel of Pachkelguri, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 21.07.22 in between 18.25 hrs to 19.55 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused namely Mahtab Khan (27 yrs) S/O Bhuttan Ahamed of Vill- Nakaha No-1, PO- Maharipur, PS- Chiluatal, Dist.- Gorokhpur, Uttar Pradesh A/P residing at Darjeeling Truck Line Hotel of Pachkelguri, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
