Sir,

In producing here with the one arrested accused Bishmati Singh @ Mina Singh (43 yrs) w/o Babu Singh of Tikiapara, Matangini II ward no 28, PS- Siliguri Dist- Darjeeling along with Nine (09) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 09 = Rs1080/-)

I ASI Debasish Das S/O Haripada Das of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused namely Bishmati Singh @ Mina Singh (43 yrs) of Tikiapara, Matangini II ward no 28, PS- Siliguri Dist- Darjeeling to the effect that on 21/07/2022 during Special Drive duty (vide Siliguri PS GDE no 1370 dated 21/07/2022) I received a source information at about 14.35 hrs from Tikiapara, ward no 05 under Siliguri PS, that one lady namely Bishmati Singh @ Mina Singh w/o Babu Singh, of Tikiapara ward no 28 under Siliguri PS, is selling huge quantity of liquor illegally in her house to his design customers since long, for her wrongful gain. After sharing the information with I/C Siliguri PS and as per his kind direction, I along with ASI Siben Sarkar, ASI Rabin Lama, L.C 1295 Swastika Rai CV/ 622 Ramanath Barman, CV/263 ASI Prasenjit Dey proceeded to the P.O to work out the source information. At about 14.50 hrs I along with my police team reached at Tikiapara, Matangini II, ward no 05, on being identified by the source our police team held raid in the House of Bishmati Singh @ Mina Singh and managed to apprehended the said lady with the help of lady force, and recovered Nine (09) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. On interrogation she disclosed her identity as Bishmati Singh @ Mina Singh (43 yrs) w/o Babu Singh of Tikiapara, Matangini II ward no 5, PS- Siliguri Dist- Darjeeling and she admitted that she sell the same to her design customers since long for her wrongful gain. On demand she failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz: Nine (09) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 09 = Rs1080/-) from the possession of Bishmati Singh @ Mina Singh (43 yrs) of Tikiapara, Matangini II ward no 28, PS- Siliguri Dist- Darjeeling the seizure and labelled was made between 15.05 hrs to 15.40 hrs in presence of witnesses duly sign by the accused as well as witnesses. As she violated the rules and norms of Bengal Excise Act, as such I arrested her u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Bishmati Singh @ Mina Singh (43 yrs) of Tikiapara, Matangini II ward no 28, PS- Siliguri Dist- Darjeeling under proper section of law.
