Sir,

In producing here with the one arrested accused Suresh Roy (51) s/o Late Ram Sirist Roy c/o Iswar Prasad of Ramghat, Natun Para w/o 5 PS- Siliguri Dist- Darjeeling along with Eleven (11) sealed bottle of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-)

I ASI Siben Sarkar S/O Raghu Pada Sarkar of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Suresh Roy (51) s/o Late Ram Sirist Roy c/o Iswar Prasad of Natun Para w/o 5 PS- Siliguri Dist- Darjeeling, to the effect that on 21/07/2022 during Special Drive duty (vide Siliguri PS GDE no 1370 dated 21/07/2022) I received a source information at about 16.20 hrs from Ramghat w/no 5 under Siliguri PS, that one person namely Suresh Roy, of Ramghat, ward no 05 under Siliguri PS, is selling huge quantity of liquor illegally at Ramghat, under Ramghat Bridge ward no 05 under Siliguri PS to his design customers since long, for his wrongful gain. After sharing the information with I/C Siliguri PS and as per his kind direction, I along with ASI Siben Sarkar, ASI Rabin Lama CV/283 Prasenjit Dey, C/V 622 Ramanath Barman proceeded to the P.O to work out the source information. At about 16.35 hrs I along with my police team reached at Ramghat, under Ramghat Bridge on being identified by the source our police team held raid and managed to apprehended the said person, and recovered Nine (11) sealed bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. On interrogation he disclosed his identity as Suresh Roy (51) s/o Late Ram Sirist Roy c/o Iswar Prasad of Ramghat, Natun Para, w/o 5 PS- Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz: Eleven (11) sealed bottle of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 11 = Rs1320/-) from the possession of Suresh Roy (51) s/o Late Ram Sirist Roy c/o Iswar Prasad of Ramghat, Natun Para, w/o 5 PS- Siliguri Dist- Darjeeling, the seizure and labeled was made between 16.50 hrs to 17.25 hrs in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I therefore pray before your kind honour to take legal action against the arrested Suresh Roy (51) s/o Late Ram Sirist Roy c/o Iswar Prasad of Ramghat, Natun Para, w/o 5 PS- Siliguri Dist- Darjeeling under proper section of law.


