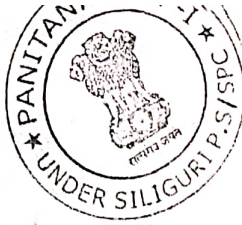

Sir,

In producing herewith one arrested accused person namely Rakesh Kurmi (27/M), S/O- Lt. Ramesh Kurmi of Bidhan Road Near Kanchanjungha Lodge, Ward No. 11, PS- Siliguri, Dist- Darjeeling along with seized articles (i) 14 (Fourteen) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD content 300 ml each when packed, MRP Rs. 60/- each. (ii) 07 (Seven) Bottle of Galaxy Boss 60 Up Country Sprit each content 600 ml when packed, MRP Rs. 120/- each. (iii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I) & (II).

I, SI Uday Shankar Mandal of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 21/07/2022 at 16:45 hrs I received secret source information that, one person is selling huge quantity of country spirit at Bidhan Road Near Hotel Doll Inn under Panitanki TOP. Accordingly I informed the information to OC Panitanki TOP vide PNT TOP GDE No. 480 dated- 21.07.2022 and as per his direction I along with C/1036 Gopal Srivastav and CV-1007 Jiten Roy left for TOP to work out the information. On arrival at Bidhan Road Near Hotel Inn at 16:55 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of witnesses namely (1) Jayanta Roy (38/M) S/O- Biki Roy of Bidhan Road Near Kanchanjungha Lodge, Ward No. 11, PS- Siliguri, Dist- Darjeeling and (2) Dilip Gatraj (29/M) S/O- Lt. Raju Gatraj of Haiderpara, Prashanti Math, Ward No. 41, PS- Bhaktinagar, Dist- Jalpaiguri. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Bidhan road adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I intercepted the said person with loaded articles in presence of witnesses. On search I recovered (i) 14 (Fourteen) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD content 300 ml each when packed, MRP Rs. 60/- each. (ii) 07 (Seven) Bottle of Galaxy Boss 60 Up Country Sprit each content 600 ml when packed, MRP Rs. 120/- each. (iii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I) & (II).

On interrogation he failed to produce any valid documents/license in support of the same and stated that he sailed the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 14 (Fourteen) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD content 300 ml each when packed, MRP Rs. 60/- each. (ii) 07 (Seven) Bottle of Galaxy Boss 60 Up Country Sprit each content 600 ml when packed, MRP Rs. 120/- each. (iii) 01 (One) Nylon Bag which used for carrying the seized articles SL No- (I) & (II) under proper seizure list and labeled the same in presence of above noted witnesses and duly sign by them and also by the accused person and arrested him. The seizure was made between 17:05 hrs to 17:45 hrs and arrested the accused person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1680/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Rakesh Kurmi (27/M), S/O- Lt. Ramesh Kurmi of Bidhan Road Near Kanchanjungha Lodge, Ward No. 11, PS- Siliguri, Dist- Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
