In producing herewith one (01) arrested accused persons namely (i) Debaprasad Bera (39yrs) S/o- Nabakumar Bera of Kanjiakhali, PS- Uluberia, Dist- Howrah West Bengal A/P Jyotinagar Colony Ward no- 41, PS- Bhaktinagar, Dist- Jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

i) 02 bottles of Johnnie Walker Black Label each amounting Rs 2830/-, Total valuation Rs 5660/ each containing 750 ML each.

ii) 04 bottles of Teachers Highland Cream each amounting Rs 1790/-, Total valuation Rs 7160/ each containing 750 ML each.

iii) 04 bottles of Teachers 50 each amounting Rs 2350/-, Total valuation Rs 9400/- each containing 750 ML each.

iv) 04 bottles of VAT 69 amounting Rs 1680/-, Total valuation Rs 6720/- each containing 750 ML each.

v) 08 bottles of 100 PIPERS amounting Rs 1690/- Total valuation Rs 13520/- each containing 750 ML each.

vi) 04 bottles of Ballantines amounting Rs 1890/-, Total valuation Rs 7560/- each containing 750 ML each.

vii) 04 bottles of ABSOLUT VODKA amounting Rs 1790/-, Total valuation Rs 7160/- each containing 750 ML each.

xi) 06 bottles of Corona extra amounting Rs 185/-, Total valuation Rs 1110/- each containing 330 ML each from the above noted bottles one sealed bottle of sample and labeled accordingly.

I, PSI Sumit Rawat S/o- Puran Rawat of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint after producing the above noted accused persons namely Debaprasad Bera (39yrs) S/o- Nabakumar Bera of Kanjiakhali, PS- Uluberia, Dist- Howrah West Bengal A/P Jyotinagar Colony Ward no- 41, PS- Bhaktinagar, Dist- Jalpaiguri to the effect that on 21.07.22 at 17.35 hrs received a secret source information that a huge quantity of liquor had been storing and selling at The Imperial Inn Hotel \$ Banquet situated at Jalpaimore under Siliguri PS. Accordingly I informed the matter to IC Siliguri PS and diarized the same in Siliguri PS General Diary vide GDE no- 1386 dated 21/07/2022. There after I along with other officer and force and Excise Department of Siliguri Circle were jointly held raid in the "The Imperial Inn Hotel \$ Banquet". During raid apprehended one person who on being asked identified himself as noted above and found him possessing above noted seized Liquors which was kept concealed at his shelf.

While conducting special joint raid against illicit liquor at The Imperial Inn Hotel and Banquet on the strength of secret source information and found that Debaprasad Bera, Cashier of The Imperial Inn Hotel and Banquet had storing and selling huge quantity of Liquor which was kept concealed at the Shelf of the Hotel.

On interrogation he admitted that he had been possessing the above noted seized articles and selling it to the customers in his Hotel. In presence of witnesses, on being demand the said person failed to produce any valid documents or license of the said liquor. Finding no alternative way I seized the 63 bottles of Liquors total market value of Rs 63175/- only (Sixty three thousand One Hundred Seventy Five only) after proper list in presence of available witnesses and duly signed by them and the whole seizure was made in between 18:45hrs to 19:15hrs and I arrested him U/S 41 CrPC under proper memo of arrest informing his ground of arrest

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Debaprasad Bera (39yrs) S/o- Nabakumar Bera of Kanjiakhali, PS- Uluberia, Dist- Howrah , West Bengal A/P Jyotinagar Colony Ward no- 41, PS- Bhaktinagar, Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigation.
