Sir,

In producing herewith one arrested accused persons namely Nabin Chettri 35yrs s/o Late Lal Bahadur Chettri R/o Lowerbang busty PO+PS, Kalimpong Dist, Darjeeling along with seized articles:-

1. Ten (10) Bottles Country Spirit styled as Himalayan Gold 60 UP each content 600 ml, MRP Rs. 120/-
2. One (01) Nylon Bag which used for carrying the seized articles SL. No. 1

I, ASI Surojit Mallick of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that on 21.07.2022 at 20.25 hrs received one secret source information to the effect that one person is carrying huge quantity of bottled country spirit through Sevoke Road near Guruduwara, Siliguri. Accordingly the information was diarized vide Panitanki TOP GDE No. 485 dated- 21.07.2022 and informed to O.C., Panitanki TOP and thereafter as per his instruction I along with, ASI Biswajit Ghosh, C/984 Subhasish Das, CV-1009 Manoj Thakur and evening K-28 van party left from Panitanki TOP to work out the information. On arrival in front of Sevoke Road near Guruduwara Siliguri at 20.35 hrs being pointed out by the source, found that one person is possessing with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person along with articles mentioned above on search the disinterested witnesses none person could be found on that area. Accordingly, I search in presence of police team and recovered huge quantity of illicit liquors on his bag. During interrogation he failed to produce any documents/license in support of the same and stated that he sale the same to the local public at Sevok road beside Guruduwara adjacent area illegally with a view to earn huge money for his wrong full gain. Accordingly, I seized Ten (10) Bottles of Country Spirit styled as Himalayan Gold 60 UP each content 600 ml, MRP Rs. 120/- and 2) One Nylon Bag which used for carrying the seized articles SL. No. 1 under proper seizure list and labelled the same in presence of raid party and duly sign by them and also by the accused person. The seizure was made between 20.40 hrs to 21.10 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also very much annoyed with him for his illegal activities and business. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances, I am submitting this written complaint against the above accused person namely Nabin Chettri 35yrs s/o Late Lal Bahadur Chettri R/o Lowerbang busty PO+PS, Kalimpong Dist, Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
