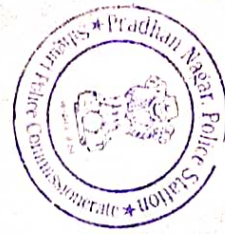

With due respect and humble submission, in producing herewith one accused namely Manoj Biswas (20) S/O Sri Bimal Biswas of Samarnagar battala, P.S- PDN, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) **15(Fifteen) Plastic bottles of Himalayan Gold, Country Spirit, 60* up each bottle containing 600 ML**

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today i.e on 21.07.22 myself along with force CV/645 Pankaj Gupta, CV/646 Baban Das all of Pradhannagar PS left for evening Patrolling duty at PS area, Vide Pradhannagar PS GDE No.1235 dtd.21.07.22 and during patrolling duty at 14.25 hrs, I received a source information that one person named Manoj Biswas was storing and selling liquor illegally in his petty shop at Samarnagar battala under Pradhannagar PS. Accordingly I share the information with you, and as per your direction rush to the spot and as pointed by the source we apprehended the above noted person and on search his shop, recovered above noted articles, On demand he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for her illegal gain. Accordingly, I seized & label the above noted articles in between 14.45 hrs to 15.15 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Manoj Biswas (20) S/O Sri Bimal Biswas of Samarnagar battala, P.S- PDN, Dist. Darjeeling and arrange for its investigation.
