In producing herewith one accused person named Rina Oraon (42) W/O- Mithu Oraon of Ramkrishna Pally , Ward No- 47, P.S- Pradhannagar, Dist- Darjeeling, along with the following seized articles :-

(1) 13(Thirteen) plastic bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufacturing by Himalayan Endeavour PVT. Ltd. Siliguri , West Bengal. .

I, SI Khela Murmu of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Rina Oraon (42) W/O- Mithu Oraon of Ramkrishna Pally , Ward No- 47, P.S- Pradhannagar, Dist- Darjeeling to the effect that on 21/07/2022 at 13 :45 hrs. Received a specific input from the source that the above noted person has kept huge quantity of illicit liquor in her house situated at Ramkrishna Pally for selling the same to her customers . Accordingly the fact is diarized vide Pradhannagar P.S. G.D.E. NO-1231 date 21/07/2022, and informed the fact to you. As per your direction I along with SI Yugel Lepcha, ASI Madan Rishi , L/C-1280 Bhakta Kumari Gurung and L/C-1586 Uma Roy left for Ramkrishna Pally under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned her house where he kept illegal alcohol. On arriving there found the above noted person who disclosed her name & identity as noted above who kept the same at her house in conceal position. On searching found 13(Thirteen) plastic bottles of Himalayan Gold 60 up country spirit containing 600 ml. each manufacturing by Himalayan Endeavour PVT. Ltd. Siliguri , West Bengal .On being interrogation she could not produce any valid documents in respect of the said illicit liquor for selling and & storing the same. Shee also stated that she is doing this liquor business since last 04 months for her wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 14:55 hrs to 15:20 hrs. On being asked she stated that she kept the same with a view to sale and supply Ramkrishnapally area without any valid documents. As she has violated the rules and norms of Bengal Excise Act as such I arrested her with help lady constable after observing all sorts' rules for selling the said country made spirit without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Rina Oraon (42) W/O- Mithu Oraon of Ramkrishna Pally , Ward No- 47, P.S- Pradhannagar, Dist- Darjeeling as per proper section of law.
