In producing herewith one accused person named Rajesh Yadav (22) S/O- Sambhu Yadav ,C/O- Basna Choudhury of Nayabusty Shalbarai ,P.S- Pradhannagar,Dist- Darjeeling, P/A- Naxalbari Stationpara P.S- Naxalbari ,Dist- Darjeeling along with the following seized articles :-

- (1) 13(Thirteen) bottles of Kingfisher Strong premium beer each bottle contains 650 ML. brewed & bottled by United Breweries Ltd. , Vittal Mallya Road ,Kalyani , West Bengal .

I, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Rajesh Yadav (22) S/O- Sambhu Yadav ,C/O- Basna Choudhury of Nayabusty Shalbarai ,P.S- Pradhannagar,Dist- Darjeeling, P/A- Naxalbari Stationpara P.S- Naxalbari ,Dist- Darjeeling to the effect that on 21/07/2022 at 14 :25 hrs. Received a specific input from the source that the above noted person has kept huge quantity of illicit liquor in his Restaurant name & style as "Rai Restaurant" situated at Shalbari in order to clandestinely dispose the same. Accordingly the fact is diarized vide Pradhannagar P.S. G.D.E. NO-1235 date 21/07/2022, and informed the fact to you. As per your direction I along with SI Abhisekh Theengh , CV 223 Swapan Chettri and CV-128 Ajoy Sahani left for Samarnagar Market under Pradhannagar P.S to verify the veracity of the information. On reaching there and as identified by source cordoned the Restaurant where he kept illegal alcohol. On arriving there found the above noted person who disclosed his name & identity as noted above who kept the same at his Restaurant in conceal position. On searching found 13(Thirteen) bottles of Kingfisher Strong premium beer each bottle contains 650 ML. brewed & bottled by United Breweries Ltd. , Vittal Mallya Road ,Kalyani , West Bengal .On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 06 months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 15:05 hrs to 15:35 hrs. On being asked he stated that he kept the same with a view to sale and supply at Shalbari area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Rajesh Yadav (22) S/O- Sambhu Yadav ,C/O- Basna Choudhury of Nayabusty Shalbarai ,P.S- Pradhannagar,Dist- Darjeeling, P/A- Naxalbari Stationpara P.S- Naxalbari ,Dist- Darjeeling as per proper section of law.
