I, **Miss. Sita Thapa, (mobile no.6294401557)**, aged 29 years
,D/O, Late Dipak Thapa of Salbari Haat, P.O:- Salbari, P.S:- Pradhan
Nagar, District:- Darjeeling, beg to report you the following facts:-

Sita Thapa

1. That one Labsang Bhutia of Monteviot Road, below Gdness Hall, ward no. 13, P.O & P.S:- Kurseong, District:- Darjeeling, raped me on the promise of marry me and at the time of such raped he took videos and photos of such rape scene.
2. That when I requested him marry me, he threatened me to make viral such photos and videos of such rape scene.
3. That I lodged F.I.R against him at Pradhan nagar P.S on 13/05/2022, vide Pradhan nagar P.S Case no. 355/2022,dt.13/05/22, u/s 376/417 of I.P.C.
4. That said Labsang Bhutia got bail under section 439 of Cr.P.C in the said case from the Higher court and by virtue of the aforesaid bail order on surrender before the Ld. Additional Chief Judicial Magistrate at Siliguri. He obtained/got regular bail.
5. That since said Labsang Bhutia has been constantly threatening me by saying that he will murder me.

5. That since said Labsang Bhutia has been constantly threatening me by saying that he will murder me.

As a matter of facts, on 03/07/2022, at about 10 p.m (night) said alleged person and his present wife, namely Dawa Kyipa Bhutia and his brother illegally entered my house and suddenly assaulted me and said Labsang Bhutia disrobed me in front of his said wife, indeed, he (Labsang Bhutia) touched my breast and rubbed it for some times and caught my different sensitive parts and outraged my modesty. Said wife of Labsang bhutia, namely, Dawa Kyipa Bhutia and his Brother snatched gold neck chain weighing 1 (one) bhoris from my neck and took Rs. 30,000/- (Rupees Thirty Thousand) from under the quilt of my bed(where I kept the same) ,however, I received severe injuries on my respective persons for such assault upon me. At that time, I screamed and then when they realized that the nearby persons are coming at the P.O, hearing my screaming, they went away from there, but before leaving the spot, they gave a open threat warning that they will again come into my house, if, I do not withdraw the said case in near hand and if I give any statement and any evidence against him(Labsang Bhutia) in Court.
