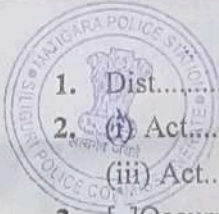



Resident of Upman apartment 5-4-C.

Respected Sir,

With all due respect, I, Dr. Priyanka Gupta
wife of Dr. Sankalp Kumar, resident of Upman
apartment 5-7-D, Uttorayan, this is to bring to
your notice that I was assaulted by Mrs.
Sujata Bhadran, resident of said apartment
for no reason of mine. We are in process of
making our home, 5-7-D. In process of that
we were carrying costly items via lift. This
lady objected of us ^{for} carrying this item. In return
we asked her 'Who are you for objecting us
for in lifting these stuffs. She stopped the lift
and started filming me and my husband
without any permission of ours. On objecting
I taking her camera in my hand. She
started screaming and hit me on my face.
Both of us retaliated. In doing so she kicked
me on lower abdomen and tried to choked
me with my scarf. I am post-partum women
P.F.O

CCS done on 21st June '20. I am gravely
hurt by this action of unprovoked hitting of
this woman for no any fault of mine. I
request the Matigara Thana to look into
the matter and take severe action on it.
They are circulating my videos and constructing
false scenario to put me and my husband
in jeopardy. They generally tell people
in society that they are placed at a very
high level post in RAW. She also threatened
the security guard who confessed the whole
scenario in front of Upwan committee.

In the above mentioned incident, her
husband and herself are very influencing and
have been involved in above kind of incident
many a times in the society.

I request you to take strict action
and save us from these high ranking people
of Police / RAW.
