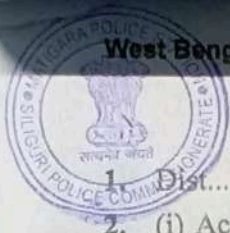

Sir

I Smt. **PRATIMA SINGHA**, wife of Shri Sushil Singha of Chaitanyapur, P.O- New Rangia, P.S- Matigara, Dist- Darjeeling informing you that on 17<sup>th</sup> July 2022 my daughter **DIYA SINGHA**, aged about 18 years at about 3:00 pm went to a Computer café at Shiv Mandir to do some online form fill up, even at 7:00 pm she did not return and then we started to search her and came to know that one **SOURAV SHARMA**, aged about 19 years, son of Ashit Sharma of Suryasen Pally (Shiv Mandir), P.O- Kadamtala. P.S- Matigara, Dist- Darjeeling forcefully took my daughter from that café and detained her in to his residence.

I along with my husband went to his residence at about 8:00 pm and found that my daughter was married and then we asked her to go with us but she denied and said that she came there with Sourav and she is now his wife. After knowing the fact we left the spot and verbally informed the matter to the Police.

On the very next day i.e. 18-07-2022 at about 9:30 AM I had received few calls from an unknown number 7076569032 where from my daughter made few calls to me and said that she was kidnapped by the said **SOURAV SHARMA** and he compelled her with force to marry him. In this matter Panchami Kundu wife of Ashit Sharma of Suryasen Pally (Shiv Mandir), P.O- Kadamtala. P.S- Matigara, Dist- Darjeeling, Deep Sharma Ashit Sharma of Suryasen Pally (Shiv Mandir), P.O- Kadamtala. P.S- Matigara, Dist- Darjeeling, Subham Paul, Supriyo Das @ Raja, Bappa Chakrabarty, Mithu Ghosh, Haripada Singh and Binod Singha@ Kalthu helped him.

We have rescued our daughter from the residence of **SOURAV SHARMA** at about 4:30 pm on 18-07-2022 and found her very weak with the sings of injury. But they have not given back the phone and the bag where all the important documents were inside the bag (Aadhaar card, voter card, educational documents along with Rs 4500). Thereafter we are being threatened by the above named persons for dare consequences and acid attack. My daughter was heavily beaten while she was in their unlawful custody.


Therefore you are requested to take necessary legal action against the wrong doers.
