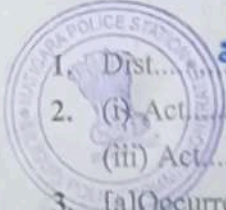

Sir,

I, Shri Nitya Sundar Roy Choudhury, Son of Late Binoy Roy Choudhury, resident of College Para within the P.O. and P.S. Siliguri, District - Darjeeling, do hereby lodge this F.I.R. on the following effects with the request for taking immediate action -

1. That I am the owner of the below Schedule Land by virtue of a Title Deed being No. I-5074/2020 executed by IDBI Bank.
2. I state that after purchase, the Vendor Bank has handed over the physical possession of the said land in my favour but unfortunately bit by bit the adjacent Government Land attached to the front portion of my said land has been unauthorisedly occupied recently by the Land Mafia Padam Rasouily [Ph. No. 93825-23098], Ghosh Villa, Near N.B.M.C & H, Kawakhari, P.O. Sushrutanagar, District Darjeeling and despite my request the said culprit together with some other land mafia namely Utpal [Ph. No. 88128-90830] who is the son-in-law of Padam Rasouily and residing in Ghosh Villa, Near N.B.M.C & H, Kawakhari, P.O. Sushrutanagar, District Darjeeling did not stop their illegal act rather **threatened me for murder** and being frightened I was silent for few days but the encroachment of the above named land mafias has reached to such an extent, finding no option I am writing this F.I.R. before you with the request to do the needful and to start a specific criminal case for committing the offence and to arrest them immediately.

3. I further request to do the needful so that the above referred Land Mafias shall abstain from capturing my land and I also requested to take appropriate actions so as to make free from entrance into my land dismantling the unauthorized "Hut" which blocked the entry into my Land made by the Land Mafias.
