Dear Sir,

With due respect I the undersigned Sri Dhrubajyoti Paul, elder brother of Debashish Paul would like to inform you that my younger brother Debashish Paul, entered into the marriage with Smt. Sukanya Paul, D/o Sri Nirmal Basak of Suryasikha Sarani, Ward No.39 under S.M.C., Near Bibek More, Silisia Sporting Club, P.S. Bhaktinagar, Siliguri, Dist. Jalpaiguri and said marriage was solemnly arranged on 01.02.2018. After the said marriage my said brother brought her in his place Pritilata Sarani, Haiderpara, Ward No.39 under S.M.C., P.O. Haiderpara, P.S. Bhaktinagar, Dist. Jalpaiguri and they started to live together as husband and wife in the joint mess with myself, my old parents together. From the very inception of the said marriage I along with my family members found that the wife of my brother started to torture upon my brother both in mentally and physically just without any reasonable cause and whenever my brother tried to convince her not to misbehave with him like that manner, she used to more violent and used to abuse filthy languages and misbehave including physically harassment and she frequently used to leave her matrimonial place and take the shelter to her parents. Whenever my brother tried to convince her parents and other family member like, (i) Sri Nirmal Basak, (ii) Lipika Basak, (iii) Sunil Kumar Basak @ Parimal (her uncle) to send his wife in his place with a advice to stop such illegal act and activities but it was very painful for my brother that without discharging their duty as the guardian, more so

they used to instigate her and also used to accuse my brother with false, defamatory, imaginary and baseless allegations.

I would like to further inform you that my brother tried his level best to discharge his matrimonial duty as a duty bound husband and he took the necessary steps for the proper medication of her unnatural behavior and activities and somehow he managed to bring back his wife in his place and out of the said wedlock she gave birth a female child on 20.04.2022 and after the birth of said new born baby, his wife along with her parents and said uncle have started to in human torture upon my brother bringing false allegations of extra marital affairs and left my brother and inspite of several attempt of request she did not return back with the direct instigation of her parents and said uncle and they did not allow my brother to touch his daughter and due to such unbearable torture my brother committed suicide in the morning and he left a suicide note in a diary (**Original suicidal note is enclosed herewith**).

Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.
