Sir,

I, **SRI BHARAT SONAR**, Son of Late Jaleswar Sonar, resident of Gital Para, Post Office – Haiderpara, Police Station – Bhaktinagar, District – Jalpaiguri, would like to inform you the following facts:-

1. That I am the registered owner of the below scheduled land, by virtue of a registered Deed of Conveyance, being Document No. 3705 for the year 2005.
2. That in the meantime, we mutated our name with the Record-of-Rights and the concerned departments have also issued separate L.R. Khatians, vide L.R. Khatian Nos. 139 and we are also enjoying the right, title and interest and peaceful possession over there having permanent, heritable and transferrable right.
3. That few miscreants namely Animesh Chandra and his wife Mina Chandra, resident of Rathkhola More, Chandra Mansion, P.O. Rathkhola, P.S. Siliguri, District - Darjeeling, Siliguri-734001 have been trying to forcefully enter my land, have been disturbing the peaceful possession of my land and have also accumulated bamboo sticks, sand and other construction materials outside my land premises to construct a hut therein and take illegal possession of my land.
4. That on several occasion we tried to restrain them but they are hell bent and continue to time and again appear outside my land to create some or the other disturbance to the peaceful possession of my land.
5. That the miscreants knowing that the value of the land has been increasing considerably over time have now hatched a plot in collusion with each other to illegally enter into my

land and forcefully take possession of the same and try to change the nature of the land to gain bargaining power against me and that the said persons are well known land grabbers.

6. That in this situation finding no other alternative I come before you.

Therefore, it is my humble request to you to register the complaint and to take immediate legal action for illegal acts and activities by the above named persons.
