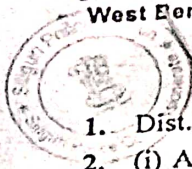

Sir,
I, Subhadeep Dutta, son of late Rabindranath Dutta and late Bharati Dutta, resident of Mahananda Para, Burdwan Road, W.No. 6, H.No. 24/233, P.O. & P.S. Siliguri, Dist. Darjeeling, West Bengal hereby lodge this complaint against Debdeep Dutta (DEBDEEP Dutta) - s/o late Rabindra Nath Dutta and Rinku Pal, both resident of Mahananda Para, Burdwan Road, W.No.6, H.No. 24/233, P.O. & P.S. Siliguri, Dist. Darjeeling - 734001.

That today i.e. on 22.07.2022 at around 2.30 P.M., the sforesaid Debdeep Dutta in collusion with Rinku Pal has hit me ^{on my head} with a sharp object to kill me. I have sustained huge bleeding and going through severe pain in my head region.

That today, when I was having my lunch at around 2 P.M. the said Rinku Pal started sweeping the floor with broomstick ^{near lunch table} and as a result dirty water were dropping/falling on my lunch plate. When I protested, then said Rinku Pal joined with said Debdeep Dutta started making videos on their mobile and started making utter false allegations about me. Then they stopped making videos and after that said Debdeep Dutta suddenly hit me on my head with sharp object in his hand and I could not complete ^{for receiving emergency treatment} my lunch. Then I had to go to the Siliguri Hospital after my friend came with ambulance.

I request you to take necessary steps against the sforesaid accused persons and I am also concerned about my safety and security of my life.
