1. That our above named firm purchased a well demarcated butted and bounded land measuring about 384.80 decimal appertaining to and forming part of R.S. New Jalpaiguri in the District of Jalpaiguri by virtue of a Deed of Conveyance duly registered in the office of the Additional District Sub Registrar, Bhaktinagar on 3/06/2022 being document No. 5575 for the year 2022.
2. That since purchase the above named firm is having right, title, interest, ownership and is in actual, peaceful, Khas possession of the aforesaid land.
3. Sir, the aforesaid land was purchased by our company to bring in factory/ industry (MSI) over there which in turn will not only generate employment opportunities but also bring all round development in the locality.
