**Sub: Legal Intervention against suspected Forgery of company documents and subsequent offences as mentioned below.**

I am the authorized representative working on behalf of the above mentioned Bajaj Allianz General Insurance Company hereinafter called as 'Company'. The company is into the field of General Insurance and we also cater Motor Insurance policies.

On 05-JUL-2022 we have received notice from Honorable MACT Kalimpong that one motor accident claim was registered against our insured company for vehicle number WB23C9548 . On perusal of the petition copy it is found that a policy number 'OG-22-0324-1859-127203508 is mentioned in the petition for the above vehicle. After our detailed scrutiny it is found that no such policy was issued to the alleged vehicle WB23C9548 Valid upto 4-7-22. This policy numbered 'OG-22-0324-1859-127203508 was not dispensed at outset of our company nor have we authorized anyone to do the same. Further on the Transcript of Proposal for Liability Only Policy for Two Wheeler was issued on the online request of vehicle owner having Policy no OG-22-9906-1806-00132703.
